A brief review of club invoicing and payment policies:

Work Hours that are not worked are billable at \$25.00 per hour. When changing from Active to Social/Resign please beware aware that hours not worked will be invoiced.

**Electronic invoicing is available.** Electronic invoicing is the preferred method as it eliminates postage fees and the member volunteer work to print an invoice, and stuff, stamp and mail an envelope. Electronic invoicing is also more environmentally friendly, eliminating the ink and paper waste. Invoices may be sent to your e-mail address. If you would like to change your account to receive electronic invoices, please make your request by sending an e-mail to [bvycacctspayable@gmail.com](mailto:bvycacctspayable@gmail.com).

Credit card payments are an acceptable form of payment for club invoices. Credit card payments may be made only at the bar during business hours. However, there is a fee for making credit card payments as follows: \$5.00 for a charge of \$0 - \$150, \$10.00 for a charge of \$150.01 - \$499.99, and \$15.00 for a charge of \$500 and above.

Annual billings are scheduled as follows:

- April - Dock Surcharge for all Active members and a Dock Fee for all permanent dock holders.
- October/November – Winter Storage fee for members who store their boats at BVYC.
- December – Annual membership dues for all Active and Social members.
- Additional billings occur in July and January for members who have not performed the minimum required work hours in the first and second halves of the year, respectively.

Invoices are due and payable within 30 days of the invoice date. Invoices not paid within 30 days are late. A report listing the member numbers of those whose account balances are late is posted weekly in the clubhouse.

Club policy regarding late payment is covered by BVYC Constitution & ByLaws Article XV, Section 1. Invoices not paid within 90 days of the invoice date, or within 60 days of the due date will cause a member to incur a 10% penalty on the late amount, be suspended from membership, and have their name placed on the "Delinquent List" of members under suspension which is posted in the club house. A certified letter will be mailed to delinquent members; if the balance including the 10% penalty is not paid within 30 days of the date of the letter, the membership will be terminated. Please refer to the BVYC Constitution & ByLaws for full details.

If you have had a change of postal address, phone number, e-mail address or other personal information ensure that you inform the Vice Commodore so that the club roster may be updated with your current information. Incorrect address information causes delayed delivery of invoices.


