

#### From the Board of Trustees

The docks that I referenced in the March Bay Views that were supposed to have been posted on March 13th were actually posted one week later, on March 20th. I apologize for this oversight and any inconvenience it may have caused you. During the February Board meeting an additional interpretation was rendered. Dock & Harbor rule #25, 1st paragraph states, in part "pilings must be in the water and securely fastened to the dock by May 1st". This rule may easily be interpreted differently by those who read it, as a specific time of day is not stated. Similarly, the 2nd paragraph states, in part, "All temporary pilings shall be detached from the dock by November 15th". This rule may also be interpreted differently for the same reason. The Board's interpretation of this rule is that if pilings are attached by 11:59 PM on May 1st a member is in compliance with the rule. Likewise, if pilings are detached by 11:59 PM on November 15th, a member is in compliance with the rule. Please, do not place used shrink wrap in a club dumpsters. Additional guidance regarding shrink wrap disposal is forthcoming. On a related note, personal items shall not be disposed of in club dumpsters; this includes, but is not limited to, kitchen sinks, sofas, doors, water heaters, etc. Of course, members may dispose of their boat trash in club dumpsters. "I do solemnly swear to uphold the Bay View Yacht Club work plan." This is part of the oath of membership sworn to by every Active member. Time spent working on club activities is a great way to meet other members, make lasting friendships, get involved in all that our club has to offer, and to have fun. I like to call them Fun Hours. However, work hours are also an obligation to the club, similar to dues. When a member resigns his/her Active membership with hours not worked he/she owes the club for those hours at a rate of \$25 per hour, prorated to the date of the status change. So, Active members, when you consider changing to Social or resigning, ensure that your work hours are current, or be prepared to pay them. Here is a brief overview of the organization of our club. Committee chairman are the backbone of our club; they perform all of the day-to-day work that keeps our business operating. Organizationally, committee chairman and the Fleet Captain(s) are appointed by, and report to, the Commodore. Ultimately the Commodore is responsible for their performance. Additionally, the Commodore chairs the Regular meetings, is a member of the Board of Trustees and is our ambassador to the world. This is the most rewarding position one can hold. The Vice Commodore is the chairman of the Membership committee. As such he ensures that applicants for membership are investigated and interviewed by committee members. The V/C is responsible for membership status changes, maintaining the roster, ensuring that a member's dues, work hours, and entertainment coupons are properly prorated at the time of a status change, and the assignment of new members to a committee for their first year of membership. The Rear Commodore is the Entertainment committee chairman. As such he provides entertainment and/or meals for social events at the club. He has the authority to close the club up to ten times per year for events that require an admission fee. I will provide more on the club organization in a future article, lest you fall asleep reading this one. Thanks for hanging with me this far.

Spring is right around the corner and with that being said there will be lots to do in the yard to prepare before we start to launch boats. We have equipment that has to be prepared so it is ready for the launch. We have a yard that needs to be cleaned up along the fences, and buildings that will need to be maintained and painted. Our small building with the power washers needs a lot of attention.

There is a lot that everyone can come out and help with even if you do not have a boat and you like to work outside. This is also for the women members of the club that would like to work outside.

I will be having another class to certify members on the equipment. If you pass, your name will be put on the roster to run the equipment. I hope everyone will understand if I do not feel you are ready or able to run the equipment I will not put your name on the roster and the reason for that is that our equipment is getting older and it needs to be run properly and maintained properly.

The yard is going to be run a little different this year and if you have read your constitution and by-laws you will see where we are coming from.

Launching of boats can start before May 1st according to our by-laws. When your boat came out determines when you go in. Please everyone be mindful of this and if you are blocking someone that wants to go and they are ready to go in and your time of launch is up and you are not ready we will move you and charge you accordingly.

Boats this year will be launched every weekend up to June 1<sup>st</sup>, again according to the by-laws boats are to be in the water by this date. We will also launch boats every Wednesday up to this date as long as there is a crew to help or you provide your own help.

LAUNCHING OF BOATS WILL BE HANDLED AS FOLLOWS:

YOU WILL STAY AND HELP EVERYONE THAT IS ON THE LIST THAT DAY TILL THE END OF THE DAY.

IF IT IS YOUR BOAT YOU WILL CLEAN UP YOUR SHORING PUT ON THE PALLETT AND THE FORKLIFT DRIVER WILL PUT IT IN THE PROPER PLACE.

WORK HOURS WILL ONLY BE GIVEN IF YOU WORK AND REMEMBER YOU DO NOT RECEIVE WORK HOURS FOR LAUNCHING YOUR OWN BOAT.

ON THE BOARD UPSTAIRS THERE WILL BE GENERAL LAUNCH DATES ACCORDING TO WHEN YOU CAME OUT—IF YOU DO NOT REMEMBER WHEN YOU CAME OUT PLEASE JUST ASK.

The Yard rules and regulations and the sign up for launching will also be there.

AS YARD CHAIRMAN I ALSO HAVE BOATS TO GET READY BESIDES TAKING CARE OF THE YARD AND MEMBERS OF BVYC. I ALSO WANT TO ENJOY MY BOATS THIS YEAR AND THIS WHY WE ARE GOING TO TRY VERY HARD TO FOLLOW OUR RULES. HOPE EVERYONE UNDERSTANDS AND I DO UNDERSTAND THERE ARE CERTAIN CIRCUMSTANCES THAT COME UP THAT CAN NOT BE AVOIDED AND I WILL WORK AROUND THEM AS LONG AS I KNOW AHEAD OF TIME.


